



ITINERARY

Day 1: July 21, Friday: Fly to Kraków on airline of your choice.



Check-in to our hotel in Kraków Dinner & folk dancing at our hotel. Overnight in Krakow.




Day 7: July 27, Thursday:

On our way to Zakopane, we stop to shop at the Costume Factory (buy on the spot or get made to measure with shipment home). Once we arrive in the mountains we partake in an evening of folklore with the mountaineers in a traditional "Góral" Restaurant with live entertainment. Overnight in Zakopane.

Day 8: July 28, Friday:

Rafting down the Dunajec River on the border with Slovakia with our Mountain guides followed by a tour of this beautiful region in the Tatra Mountains with stunning views, wildlife and abundance of storks. Overnight in Zakopane.





We visit the Auschwitz-Birkenau Museum in Oświęcim in the morning and then continue north to the Jasna Góra Monastery where we will see Poland's holiest of shrines "The Black Madonna" in Częstochowa.
