Visit the Equestrian Museum and the Engagement Museum, then enjoy the totrally unique theatrical performance "Como Bailan los Caballos Andaluces" (How Andalusian Horses Dance.). After the show, we'll leave drive tp Seville and dinner in our Hotel Catalonia Giralda 4\*.

#### Day 7. Wednesday, September 18: SEVILLE

Morning cultural tour of Seville. Then after lunch, an exciting visit to the renown Seville Flamenco Museum. After learning more about this vibrant art form, we'll have a dance class in Sevillanas. Dinner in our Hotel Catalonia Giralda 4\*.

#### Day 8. Thursday, September 19: CORDOBA
